## Brantford Jury Awards Victim of Snow Plow Accident \$2.44 Million

he lawyers, paralegals and staff at Smitiuch Injury Law have obtained another successful outcome during a jury trial in Brantford, Ontario which began in March 2017.

Our client ("GM"), a 28 year old Brantford resident, was awarded \$2.44 million for injuries he sustained in a motor vehicle accident on March 7, 2008. GM's injuries were soft tissue leading to chronic pain and psychological issues, including symptoms of post-traumatic stress disorder.

The case involved a unique incident in which a snow plow performing winter maintenance pushed a blanket of snow and ice from an overpass onto GM's vehicle below as it drove along Highway 403. The snow and ice broke through the sunroof of his vehicle and crashed onto his head. GM was unable to continue working as a result of the accident.

Peter Cho, Associate Lawyer at Smitiuch Injury Law and trial

counsel for GM, had the following to say as to the length of time this case took to reach completion, "This case took so long because we do not leave any stone unturned and we first included everyone we thought was responsible for GM's injuries, but we later learned that different parties were responsible for different lanes. We finally narrowed it down to two defendants who eventually admitted they were responsible."

The two companies responsible were TWD Roads Management Inc. and Integrated Maintenance and Operations Inc. Both had a snow plow performing maintenance on the overpass on the day of GM's accident. However, even though these defendants finally admitted

fault for the accident, the trial still took five weeks in order to assess damages. The trial proceeded in front of a jury on March 20, 2017, and presiding over the trial was the Honourable Mr. Justice Edwards.

In the end, the jury awarded GM \$600,000.00 for pain & suffering and loss of enjoyment of life, \$950,000.00 for loss of income and \$800,000.00 for cost of care, plus other damages and expenses, totalling \$2,440,000.00. This was the second highest jury award for chronic pain in Canadian

history.

The "road" to this successful jury verdict was complex and it took great resolve on the part of the Plaintiff. Our firm committed considerable resources into this lawsuit and trial, including the use of expert medical witnesses, forensic accountants and a future cost of care expert. When an injured Plaintiff needs help obtaining justice it is essential that the law firm they retain actually will go to trial on their

## **Does Your Accident Qualify for Accident Benefits?**

ntario enjoys the benefit of a two-tiered system when someone is injured in a motor vehicle accident. If another party is at-fault, there is a tort action (lawsuit). There is also a system in place for those who are injured in a motor vehicle accident, regardless of who is at-fault. This is accident benefits. No matter who is at-fault for an accident, your own insurance company (or another, if you do not have insurance) is responsible for paying certain benefits that you are entitled to under the accident benefits policy.

We often think of a "motor vehicle accident" as a collision between two vehicles, a single-vehicle crash, or even a vehicle striking a pedestrian or bicyclist. However, the criteria for being considered a "motor vehicle accident" can encompass many more scenarios.

Below is a listing of scenarios that have been considered an "accident" and the injured party has been allowed to access accident benefits.

- Due to a street festival, a woman was forced to ride her bicycle on a sidewalk. A van was parked halfway over the sidewalk and the woman fell while riding around the vehicle, breaking her hip. The van was considered the direct cause of her injuries.
- A young man was riding his uninsured dirt bike on a

private course when he lost control and fell, resulting in an acquired brain injury.

- A man was driving a golf cart on a roadway and was involved in an accident and was injured. It was determined that the golf cart was a "motor vehicle" while it was on a roadway.
- A woman was filling her car with gas at a gas station when she slipped and fell on some ice. Since pumping gas was part of the normal operation of a motor vehicle, it was deemed to be an "accident".
- A man was riding his bicycle when he was sideswiped by an unidentified vehicle that did not stop after the collision.
- A gentleman was a passenger in a "party bus" with his friends and he decided to try, unsuccessfully, some acrobatics on a "vertical pole" on the bus, causing serious injuries. Since the pole was permanently affixed to the bus, it was considered to be part of the vehicle and the direct cause of his injuries.

If you are injured and a motor vehicle of any sort was the direct cause of your injuries, it is always best to check with a reputable personal injury law firm who can advise if you are entitled to claim accident benefits.

## Providing Legal Services in Another Province

hanks to the National Mobility Agreement negotiated amongst provincial law societies, it has become easier for Canadians to choose the lawyer of their choice – regardless of the province that the lawyer resides in.

According to the Law Society of Upper Canada, lawyers from Ontario who seek to exercise mobility elsewhere in the country must consult the law society in the jurisdiction in which they wish to exercise temporary or permanent mobility or in other words, practice law. The requirements they are subject to depend upon whether the jurisdiction in question is a member of the National Mobility Agreement and has implemented rules under that Agreement. Of note, however, is that a lawyer may practice in a member province for 100 days without having to seek the permission of the province's law society.

At Smitiuch Injury Law we have had the exciting opportunity to fight for our clients' rights from coast to coast. Last month, Matthew Nieuwland, Associate at Smitiuch Injury Law, travelled to Halifax, Nova Scotia, to represent a client injured in a wired glass incident. He successfully settled the claim. The family's son committed suicide while the hospital was treating him.
